Additionally, linemen must be dedicated to their careers. The long

hours and ever-present danger can truly take a toll. In fact, being a lineman is listed as one of the top 10 most dangerous jobs in the U.S. Plus, graduating an apprenticeship and becoming a journeyman lineman takes four years of training. Additionally, linemen often work in extreme weather conditions and through all hours of the day and night.

"I get to work with a great group of linemen who are dedicated to their craft," said Kevin Wilkerson, CHELCO Manager of Operations. "I'm proud of the work we do each day to serve our members and community."

What to look for when purchasing an EV



As the demand and popularity of electric vehicles (EVs) continue to grow, more and more people may find themselves in the market for one. Auto manufacturers are starting to develop EVs that appeal to more people. Many EVs now have longer range, more room, and some electric trucks are hitting the market with impressive towing capabilities. Consider these three questions when shopping around for a new EV: Does the vehicle meet my needs? How will I charge it? How long will I own the vehicle?

When considering an electric vehicle, you will want to check the range. The range is the distance that the vehicle can be driven on a full charge. If the range of the vehicle you are considering does not meet your typical driving needs, ask the dealer if they offer a larger battery or look into a different model.

Another thing to consider is where you will charge the vehicle. The majority of people install level two chargers at their homes, which allows them to charge the vehicle overnight and have a full battery in the morning. If charging at home is not an option, then you will need to consider the cost and time to charge the vehicle at a public charger.

Finally, think about how long you plan to own your EV before making a purchase. One major advantage of owning an electric vehicle is the limited need for service and maintenance. Talk to the manufacturer about the battery life and cost of the vehicle's batteries. Eventually, they will need to be replaced, and this alone will add a significant monetary investment to the vehicle. Research which dealerships in your area have the training and capabilities necessary to work on the EV you are purchasing.

As electric vehicles are becoming more present on the roads, more car dealerships understand the benefits, along with some obstacles, and can help you make the right decision.
